
Properties can be let if they have an energy rating from A to E.

2. Floor insulation (solid floor)	£4,000 - £6,000	£76
3. Solar water heating	£4,000 - £6,000	£71
4. Replacement glazing units	£1,000 - £1,400	£68
5. Solar photovoltaic panels	£3,500 - £5,500	£666
